

**TENDER NOTICE AGAINST CARRIAGE OF HARVESTED PRODUCE AT SHILABATI BARRAGE**

In pursuance to the G.O No-5400-F(Y) dt 25/6/12 and its subsequent amendment No-2254-F dated 24/4/14, Sri Kamal Sarkar, WBFS, Divisional Manager, Bankura Forest Corporation Division, invites tender from bonafide, resourceful Government suppliers/contractors for carriage operation of Harvested produce of 364 nos felled trees at Shilabati Barrage under Kansabati Canal Division-II in Bankura district as per the estimate mentioned in the table below.

This tender is invited against the work consists of carriage of harvested produces of 364 nos. trees already felled at the working site for the purpose of Landscaping and beautification works at Kadamdeuli Mouza, Shilabati Barrage under Bankura districts & transportation of the same to Taldangra timber depots of Taldangra FC Range under WBFDCL Ltd. The maximum admissible rates, inclusive of all applicable taxes including GST for every possible type of produces are mentioned below. The intending bidders must quote against gross rate offered here under.

## Who can participate

Any government contractor/order supplier who has credentials for similar nature of works, or allied activities to the tune of 100% of estimated amount put to tender here, in a single work as per the financial terms, executed within last three (03) financial years, may participate in bidding process. Submission of credential certificate along with tender is a must.

## Terms and conditions

1. The Tender forms along with Terms and Conditions of Tender will be available on payment of Rs. 100/- by cash from 08.10.2021 to 01.11.2021 between 11.00 am. to 05.00 pm. from the Office of the Divisional Manager, Bankura Forest Corporation Division.
2. For participating in Tender, all intending purchasers shall be required to deposit a sum of Rs. 4750/- (Rupees Four Thousand Seven Hundred Fifty Only) as Earnest Money (EMD) by Bank Draft only, drawn on any nationalized Bank payable at Bankura in favour of "Divisional Manager, Bankura Forest Corporation Division, WBFDC," at the time of depositing/dropping the Tender along with sealed Tender paper of quoted rates.
3. **Pattern of tender:** - Invitation of this tender is purely indicative in nature. The Quantity, & amount mentioned in the estimate are purely tentative in nature. The final can only be ascertained only after carriage is done in the depot and JPC and ITC is measured. Bill will be paid only after completion of work.
4. **Validity of the tender** will be 1 (One) Year from the date of submission.
5. Incomplete tender (s) will be summarily rejected.
6. The undersigned reserves the right to place order for work for 20% more or less of the quantity (if mentioned here) without providing any additional remuneration.
7. The undersigned reserves the right to cancel the tender, at any stage of it, if necessary, without assigning any reason whatsoever.
8. The undersigned is not bound to accept the lowest rate quoted by the tenderers and he is not bound to assign any reason, whatsoever, for such non-acceptance.
9. All vehicles engaged in carriage of CFC produce must be having commercial number plates and commercial licence. No vehicles having registration other than West Bengal will be allowed.
10. The vehicles for carriage must be in good conditions so that they can ply off-road and on road. All types of documents/papers, challans, certificates, payable fees for smooth and lawful plying and transport shall be the sole responsibility of the successful tenderer.. If produces get depreciated/damaged/destroyed due to those reasons or negligence during transportation, recovery will be made from the tenderer as per current schedule of rates of Directorate of Forests, Government of West Bengal including necessary penalties/ fines as the undersigned deems fit.
11. carriage works have to be finished within specified time without fail. No extension of time will be allowed for execution of the work. But the tenderer shall not be held

responsible if the delay in execution occurs due to causes beyond his / her control, such as acts of God like natural calamities, civil wars, fire, strike, frost, floods, riot and acts of unsurpassed power. In the event of delay due to such causes, the tenderer may apply for extension of time for that period. The undersigned, as per direction received from the General Manager, (HQ), WBFDC Ltd., in this regard, may extend for a length of time equal to the period of *force majeure* or such period as he thinks suitable for that or may reject the application. Such cancellation would be without any liability whatsoever on the part of the undersigned.

12. All tools & plants required for execution of the works should be procured by the contractor at his own cost.
13. All statutory deductions & cess, applicable shall be deducted from the Gross amount of Bill.
14. West Bengal Forest Development Corporation Limited, or Bankura Forest Corporation Division, or any staffs of the Division, shall in no way be held responsible under any circumstances for any accident/death of any labourer/ driver etc, due to any reason whatsoever, or damage of vehicle/other property engaged by the contractor, happened in the field during the time of implementation of the works. No liability or compensation will be upon them.
15. The mode of payment for successful completion of the works should be made by NEFT/RTGS/Cheque/Cash whichever is suitable to the undersigned.
16. **Dispute Resolution** – The decision taken by the undersigned shall be final. In case of any dispute, appeal if any, shall be made to the General Manager (Hq.) within 30 days. The decision taken by him shall be final and binding.
17. The successful tenderer will not assign any part of the work to any other contractor. Giving sub-contract is strictly prohibited.
18. Successful tenderer will be responsible for the protection for the trees/ forest produce assigned to them for extraction. The passing Challan have to be duly signed by the contractor or his authorized representative and the carriage shall be done under the cover of Intermediate Transit Challan (ITC).
19. No carriage should be done before sunrise or after sunset. No vehicle shall be allowed to remain in the work site after the sunset.
20. In case of implementation of the works at field, the decision of the Range Manager or his authorized persons or any of his superior officers shall be final and binding on the successful bidders implementing the works at field.
21. No Child labour should be engaged.

### Details of Tender Process

1. **Procurement of tender paper-** The tender paper shall have to be procured from office of the undersigned on payment of requisite fees @ Rs. 100/- per tender Paper set. The intending bidders may also visit the official website of W.B.F.D.C.L.; [www.wbfpms.com](http://www.wbfpms.com) for information.
2. **Submission of Tender -** Sealed Tenders will be receiving up to 05:00 pm. from 08.10.2021 to 01.11.2021 by Post, Courier or by hand and will be opened on the next working day 02.11.2021 at 11:00 am. The bidders are requested to be present during opening of tender. Tender should be submitted by name in favour of **Sri Kamal Sarkar, WBFS & Divisional Manager, Bankura Forest Corporation Division, W.B.F.D.C.L.** and not by official designation only.
  - i. Amount quoted more than the estimated cost will not be accepted in general, subject to the discretionary power of the undersigned or his official superior, based on the recommendation of the tender committee constituted for the purpose.
3. **Refund of EMD:** The Earnest Money of all the unsuccessful tenderers (except L1 Bidders) deposited in favour of the Divisional Manager, Bankura Forest Corporation Division will be refunded by the Divisional Manager, Bankura Forest Corporation Division upon receipt of application from tenderer(s) in due course.
4. The successful Bidder to whom a Letter of Acceptance will be issued, shall have to deposit an amount @ rate of 3% (three%) of the total tender value in form of Bank Draft in Original in favour of "Divisional Manager, Bankura Forest Corporation Division" payable at Kolkata. Failure in depositing this amount and / or in submission within the specified time shall render the contract liable to termination without reference to the contractor and in such case, the deposited earnest money shall stand forfeited to the W.B.F.D.C. Ltd.
5. The Security Deposit will be released to the contractor after at least 1 (One) months from the last date of completion of work for the project if no irregularity is noticed within this period. In case of any irregularity, the Security Deposit will be forfeited, in addition to any legal action as deem fit & required.
