

1. Background

The West Bengal Forest Development Corporation Limited (WBFDCL) (hereinafter also referred to as the "Corporation") came into existence in 1974 as per Companies Act 1956, on the recommendation of National Commission of Agriculture. The Broad Objectives of setting up WBFDCL was to offer timber, non-timber forest produces and value-added forest products at reasonable prices for the public in general, to develop awareness for conservation of nature and wild life through responsible ecotourism.

2. Selection of Agency



- The Bidder should either be Manufacturer / authorized dealers of the Brand as mentioned under Clause 1.2 above
- In case of Authorized Dealer Authorization certificate to be enclosed with this Tender.

- a. WBFDCL shall endeavor to respond to the questions raised or clarifications sought by the Bidders. However, WBFDCL reserves the right to not respond to any question or provide any clarification, in its sole discretion.
- WBFDCL may also on its own motion, if deemed necessary, issue interpretations and clarifications to all Bidders. All clarifications and interpretations issued by WBFDCL shall be deemed to be part of the Tender Document.

6. Amendment of Tender Document

- a. At any time prior to the Bid Due Date, WBFDCL may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the Tender Document by the issuance of Addenda.
- In order to afford the Bidders a reasonable time for taking an Addendum into account, or for any other reason, Corporation may, at its own discretion, extend the Bid Due Date.

7. Right to accept and to reject any or all Bids

- a. Not with standing anything contained in this Tender Document, WBFDCL reserves the right to accept or reject any Bid and to annul the Bidding Process and reject all Bids at any time during the Bidding Process without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.



- A. Envelop 1: Technical Bid: The Bidder shall submit thefollowing document as part of its

 - ii) Proof towards Manufacturing unit/ Authorized Dealer or Distributor.
 - iii) EMD/ Security Deposit.
 - iv) Trade License (in case of proprietorship firm/ partnership firm)
 - In case of Company Please enclose Memorandum and Articles of Association along with certificates of incorporation, and date of commencement of business etc.
 - vi) In case of Partnership Firm, registered under the Partnership Act., 1932 Please enclose details of partners, details of their business and partnership deed etc. duly attested by Notary
 - vii) GST Certificate
- B. Envelop 2 Financial/Price Bid: The Bidder shall submit all-inclusive financial quotes as its Financial Bid. The price bid quoted by the Bidder shall be inclusive of taxes & duties including GST. The Price Bid shall be exclusive of Freight, which will be paid on actual basis. The Price Bid quoted by the Bidder shall remain valid for 6 months.
- 10. The queries and original document must be submitted to the address mentioned in clause 8 above.

11. Bid Security

- a. The Bidder shall furnish, as part of its Bid, a Bid Security equivalent to Rs. 6000/-(Rupees Six thousand only).in the form of Bank DD/Cheque favoring Divisional Manager, Kolkata Forest Corporation Division, payable at Kolkata. Bid Security is exempted for applicants who are registered with MSME and NSIC for the services for which enlistment is sought on production of documentary evidence
- 12. WBFDCL's right to vary Scope of Work at the time of Award:
 - a. WBFDCL reserves the right to vary the quantity.

13. Terms & Conditions

- a. WBFDCL reserves the right to reject the Application/ Bid of any Bidder who is a defaulter to the WBFDC Ltd. & the Forest Directorate, W B in respect of payment of dues.
- The evaluation of the applications for empanelment shall be carried out by the committee constituted for the purpose.
- c. Any un-authenticated, alterations, erasures, overwriting, blanking out or discrepancies may render the Tender Document submission invalid. The evaluation of the response will only be based on the documents submitted and evaluation committee reserved the right to relax the evaluation criteria.





f. 
