Request for Proposal

1. Background

- 1.1. The West Bengal Forest Development Corporation Limited (WBFDCL) (hereinafter also referred to as the "Corporation") came into existence in 1974 as per the Companies Act 1956, on the recommendation of the National Commission of Agriculture. The Broad Objectives of setting up WBFDCL was to offer timber, non-timber forest produces, and value-added forest products at reasonable prices for the public in general, to develop awareness for conservation of nature and wildlife through responsible eco-tourism.
- 1.2. In order to provide convenience to the visitors, the West Bengal Zoo Development Authority has developed a Refreshment Pavilion in the Zoological Garden at Alipore, Kolkata.
- 1.3. West Bengal Forest Development Corporation Limited and West Bengal Zoo Development Authority have mutually decided to select the agency for Operation, Maintenance, and Management of the said Refreshment Pavilion in the Zoological Garden at Alipore, Kolkata.
- 1.4. WBFDCL now intends to select a suitable agency through a transparent, open, and competitive bidding process for Operation, Maintenance, and Management of the said Refreshment Pavilion in the Zoological Garden at Alipore, Kolkata.
- 1.5. Detailed information about the Refreshment Pavilion is provided in Appendix 3

2. Selection of Agency

- 2.1. WBFDCL has decided to carry out a two-part bidding process, comprising of namely, Technical Bid and Price Bids (collectively referred to as the" Bidding Process") from interested Agencies/ Bidders for selection of an Agency to whom the Project will be awarded. Only those Bidders, whose Technical Bids qualify in terms hereof will be eligible for opening and evaluation of their Price Bids.
- 2.2. This RFP contains information about the Project, Bidding Process, Bid submission, Qualification, and Financial Proposal requirements
- 2.3. The Bid shall be valid for a period of not less than 120 (one hundred and twenty) days from the Bid Due Date ("Bid Validity Period").
- 2.4. Interested Firms/ Companies who are able to comply with the requirements may submit the tender duly filled in and supplemented with all relevant documents to WBFDCL for further processing as per laid procedures. Tender not completed in any respect are liable to be rejected summarily.
- 2.5. Interested Bidder can submit their application only through electronic means, as per guidelines provided in Appendix 1.
- 2.6. The Project shall be awarded to the Bidder who submits the best financial bid (as defined in clause 12 of this document). The other Bidders will be kept in reserve and may, in accordance with the process specified in the RFP, be invited to match the bid submitted by the Preferred Bidder (who has submitted the best financial offer) in a case where the Preferred Bidder withdraws or is not selected for any reason. If none of the Bidders match the bid of the Preferred Bidder, WBFDCL may, in its sole discretion, invite fresh bids from all Bidders or annul the Bidding Process, as the case may be.
- 2.7. Tenders are to be submitted through online to the website as stated in two folders, one is Technical Proposal (BID A) & the other is Financial Proposal (BID B) [as BOQ] before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be

- uploaded virus free scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).
- 2.8. The bidders are advised to submit the bids well in advance of the deadline. WBFDCL will not be liable or responsible for non-submission of the bids or submission of incomplete bid on account of any technical glitches or any problems in connectivity services used by the bidder.
- 2.9. Any award of Contract pursuant to the Bidding Process shall be subject to the terms and conditions of Bidding Documents

WBFDCL reserves the right to modify the said schedule of the Bidding Process at any time during the Bidding Process at its sole discretion without assigning any reason or being liable for the same in any manner whatsoever.

4. Instruction to Bidders

- 4.1. The Bidder shall submit a Power of Attorney as per the format enclosed at Annexure-IV, authorizing the signatory of the Bid to commit the Bidder.
- 4.2. Any condition or qualification or any other stipulation contained in the Bid shall render the Bid liable to rejection as a non-responsive Bid. The bids shall be unconditional, firm, and irrevocable
- 4.3. The Bidders shall be responsible for all costs associated with the preparation of their Bids and their participation in the Bid. The Corporation will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process
- 4.4. Any entity which has been barred by the [Central/ State Government, or any entity controlled by it] from participating in any project, and the bar subsists as on the date of bidding, would not be eligible to submit a Bid. A Bidder including any Associate should, in the last 3 (three) years, have neither failed to perform on any contract (except due to Force Majeure Event), as evidenced by the imposition of a penalty by an arbitral or judicial authority or a judicial pronouncement or arbitration award against the Bidder, or Associate thereof, as the case may

- be, nor has been expelled from any project or contract by any public entity nor have had any contract terminated by any public entity for breach by such Bidder, or Associate thereof.
- 4.5. The Bid and all communications in relation to or concerning the Bidding Documents and the Bid shall be in the English language.
- 4.6. A Bidder shall not have a conflict of interest (the "Conflict of Interest") that affects the Bidding Process. Any Bidder found to have a Conflict of Interest shall be disqualified. In the event of disqualification, Corporation shall forfeit and appropriate the Bid Security or Performance Security (in case of Successful Bidder, after the Project is awarded to it), as the case may be, as mutually agreed on genuine pre-estimated loss and damage likely to be suffered and incurred by the Corporation and not by way of penalty for, inter alia, the time, cost and effort of Corporation, including consideration of such Bidder's proposal, without prejudice to any other right or remedy that may be available to the Corporation hereunder or/and the Contract Agreement or otherwise. Without limiting the generality of the above, a Bidder shall be considered to have a Conflict of Interest that affects the Bidding Process, if:
 - the Bidder, its Member or Associate (or any constituent thereof) and any other Bidder, its Member or any Associate thereof (or any constituent thereof) have common controlling shareholders or other ownership interest; or
 - ii. a constituent of such Bidder is also a constituent of another Bidder; or
 - iii. such Bidder or any Associate thereof has a relationship with another Bidder, or any Associate thereof, directly or through common third parties, that puts them in a position to have access to each others' information about, or to influence the Bid of either or each of the other Bidder; or
 - iv. such Bidder has participated as a consultant to Corporation in the preparation of any documents, design ,or technical specifications of the Project.

For purposes of this RFP, Associate means, in relation to the Bidder, a person who controls, is controlled by or is under the common control with such Bidder (the "Associate"). As used in this definition, the expression "control" means, with respect to a person which is a company or corporation, the ownership, directly or indirectly, of more than 50% (fifty percent) of the voting shares of such person, and with respect to a person which is not a company or corporation, the power to direct the management and policies of such person by operation of law.

5. Eligibility Criteria

- 5.1. The Bidder may be Proprietorship Firm / Partnership Firm / Private Limited Company / Public Limited Company / Limited Liability Partnership / Cooperative Society / Society / Consortium / joint venture of a maximum of two entities shall be allowed.
- 5.2. The Bidder shall have a minimum of 5 years of experience in similar nature (running of restaurants/ food court).
- 5.3. The Bidder should have a minimum annual turnover of at least Rs 3 crore in each of the last 3 financial years preceding the Bid Due Date.
- 5.4. The Bidder must also possess the following:
 - 5.4.1.Trade License
 - 5.4.2.GST Registration

5.4.3. Prevention & Food Adulteration License

5.4.4. Police License (where applicable)

6. Clarifications

- 6.1. WBFDCL shall endeavor to respond to the questions raised or clarifications sought by the Bidders. However, WBFDCL reserves the right to not respond to any question or provide any clarification, in its sole discretion.
- 6.2. WBFDCL may also on its own motion if deemed necessary, issue interpretations and clarifications to all Bidders. All clarifications and interpretations issued by WBFDCL shall be deemed to be part of the RFP.

7. Amendment of RFP

- 7.1. At any time prior to the Bid Due Date, WBFDCL may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the RFP by the issuance of Addenda.
- 7.2. In order to afford the Bidders a reasonable time for taking an Addendum into account, or for any other reason, Corporation may, at its own discretion, extend the Bid Due Date.

8. Right to accept and to reject any or all Bids

- 8.1. Notwithstanding anything contained in this RFP, WBFDCL reserves the right to accept or reject any bid and to annul the Bidding Process and reject all Bids at any time during the Bidding Process without any liability or any obligation for such acceptance, rejection, or annulment, and without assigning any reasons thereof.
- 8.2. The Corporation reserves the right to reject any Bid and appropriate the Bid Security if:
 - (a) At any time, a material misrepresentation is made or uncovered, or
 - (b) The Bidder does not provide, within the time specified by the Corporation, the supplemental information or clarification sought by the Corporation for evaluation of the Bid. Such misrepresentation/improper response shall lead to the disqualification of the Bidder. If such disqualification / rejection occur after the Bids have been opened and the successful Bidder gets disqualified / rejected, then the Corporation reserves the right to:
 - (i) Invite the remaining Bidders to submit Bids; or
 - (ii) Take any such measure as may be deemed fit in the sole discretion of the Corporation, including annulment of the Bidding Process.

The Corporation reserves the right to verify all statements, information and documents submitted by the Bidder in response to the RFP or the Bidding Documents and the Bidder shall, when so required by the Corporation, make available all such information, evidence and documents as may be necessary for such verification. Any such verification or lack of such verification, by the Corporation shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of the Corporation there under.

9. Language

9.1. The Bid and all related correspondence and documents in relation to the Bidding Process shall be in the English language. Supporting documents and printed literature furnished by the Bidder with the Bid may be in any other language provided that they are accompanied by appropriate translations in the English language. Supporting materials, which are not translated into English, may not be considered. For the purpose of interpretation and evaluation of the Bid, the English language translation shall prevail.

10. Uploading of the Bid

10.1. The bids shall be uploaded in two folders which comprise the following documents:

A. **Folder-I (Bid A) Technical Bid:** The Bidder shall submit the Technical Bid in the formats specified in respect thereto

- i) Letter Comprising the Bid in the form and manner as described in Annexure I.
- ii) Details of the Bidder in the form and manner as described in Annexure-II.
- iii) Technical Capacity of the Bidder in the form and manner as described in Annexure III.
- iv) Financial Capacity of the Bidder in the form and manner as described in Annexure IV
- v) Power of Attorney authorizing the signatory of the bid to commit the Bidder and in the format as specified in Annexure V
- vi) Statement of Legal Capacity of the Bidder in the form and manner as described in Annexure VI
- vii) Scan copy of the receipt of online payment of EMD/ Security Deposit
- viii) Trade License (in case of proprietorship firm/ partnership firm)
- ix) In case of Company Please enclose Memorandum and Articles of Association along with certificates of incorporation, and date of commencement of business etc.
- x) In case of Partnership Firm, registered under the Partnership Act., 1932 Please enclose details of partners, details of their business and partnership deed etc. duly attested by Notary
- xi) GST Certificate
- xii) Prevention & Food Adulteration License
- xiii) Police License (where applicable)

The Corporation shall not consider bid/s which are lacking in terms of the above mentioned information (information as sought under Folder A; Technical Bid).

B. **Folder-II (Bid B)** Financial/Price Bid: The Bidder shall directly submit all-inclusive financial quotes as its Financial Bid online in Folder II (Bid B) in the BOQ format as per the guidelines in response to financial criteria and the same is required to be encrypted using their Digital Signature Certificate.

12. Financial Proposal/ Bid Variable/ Price Bid

- 12.1. The Bidder shall submit its financial quotes as its Financial Bid online in Folder II (Bid B) in the BOQ format. Draft of the BOQ format is enclosed as Annexure VII.
- 12.2. Bidder quoting the highest price subject to a minimum reserve shall be selected as Successful Bidder or Selected Agency.
- 12.3. The Minimum Reserve Price (Minimum License Fee) for the Bid is Rs 4 lac/ month plus applicable GST. A bidder participating in the bid shall have to quote in excess of the Minimum Reserve Price.
- 12.4. The Price Bid to be quoted by the Bidder shall be exclusive of taxes and duties.

13. Bid Validity

- 13.1. Bids shall remain valid for a period of 120 days (one hundred twenty days) after the Bid Due Date (herein the "Bid Validity Period"). A Bid having lesser validity period than the prescribed Bid Validity Period shall be summarily rejected by the Corporation as non-responsive.
- 13.2. Prior to expiry of the Bid Validity Period, the Corporation may request the Bidders to extend the Bid Validity Period for a specified additional period.

14. Bid Security

- 14.1. The Bidder shall furnish, as part of its Bid, a Bid Security equivalent to Rs. 1,00,000/- (Rupees one lac only.
- 14.2. EMD has to be payable in ONLINE mode as per Finance Department G.O. No 3975 F (Y) dated 28th July 2017.
- 14.3. The EMD of the selected Bidder will be returned through the online payment portal as per guidelines issued by Finance Department G.O. No 3975 F (Y) dated 28th July 2017.
- 14.4. The EMD of the selected Bidder may be forfeited if the organization fails to sign the contract in accordance with the terms and conditions.
- 14.5. The Bid Security of unsuccessful Bidders, except the Bidder (H2) next to the Successful Bidder (H1) will be returned promptly without any interest, but not later than 60 days from the Bid Due Date. The Bid Security of H2 will be returned within 15 (fifteen) days of signing of Contract Agreement with the successful bidder. The EMD will be returned through the online payment

portal as per guidelines issued by Finance Department G.O. No 3975 F (Y) dated 28th July 2017.

- 14.6. The Bid Security shall be forfeited as damages without prejudice to any other right or remedy that may be available to the Corporation under the Bidding Documents and/ or under the Contract Agreement, or otherwise, under the following conditions:
 - a) If a Bidder submits a non-responsive Bid;
 - b) If the Bidder withdraws its Bid during the Bid Validity Period as specified in this RFP and as extended by mutual consent of the respective Bidder(s) and the Corporation;
 - c) If the Bidder submits a conditional Bid which would affect unfairly the competitive position of other Bidders who submitted substantially responsive Bids.
 - d) If a Bidder engages in a corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice;
 - e) If the Bidder does not accept the correction of errors in its Bid, pursuant to Clause 22 hereof;
 - f) In the case of the Successful Bidder, if the Bidder fails within the specified time limit to
 - a. To sign and return the duplicate copy of LOI;
 - b. Sign the Contract Agreement;
 - g) any other conditions, for which forfeiture of Bid Security has been provided under this RFP.

15. Opening of Bid

- 15.1. WBFDCL opens the Bids of those Bidders who have successfully submitted their bids online and will evaluate the bid in line with Clause 17
- 15.2. The Eligible Bidders will be informed of a date, time and place for opening of their Financial Bids.
- 15.3. The Financial Bids of only the Eligible Bidders i.e. technically qualified based on the criteria will be considered for evaluation on the intimated date. The Financial Bids will be opened in the presence of the representatives of the Eligible Bidders that choose to be present.

16. Examination and of Technical Bids

- 16.1. WBFDCL will determine responsiveness of the Technical & Financial Bid
- 16.2. A substantially technical bid is one which conforms to all the terms & conditions of the bid and the bidder has submitted all the relevant papers as per the requirements of this RFP
- 16.3. If the Bid of any Bidder is not substantially responsive in terms hereof, the Bid of such Bidder shall be rejected by WBFDCL and the Bidder shall not subsequently be allowed to make its Bid responsive by correction or withdrawal of the non-conforming deviation or reservation.

17. Evaluation Process

- 17.1. Only those Bidders whose Bids are found responsive in terms hereof and meets the eligibility criteria specified in Clause 5 above shall qualify for opening of their Financial Bid. Bidders whose bid does not meet the aforesaid qualification criteria shall be rejected.
- 17.2. All claims to be supported by relevant documents / certificates. Onus of substantiating claims lies with the bidder.

18. Evaluation and Comparison of Financial Bids

- 18.1. WBFDCL will evaluate and compare only those Financial Bids which are determined to be substantially responsive
- 18.2. In evaluating the Financial Bids, WBFDCL will determine for each Financial Bid the evaluated Bid Price by adjusting the Bid Price by making any correction for errors.
- 18.3. Financial Proposal of the bidders qualifying in the evaluation of Technical specification will be evaluated. The bidder who has qualified in the Technical Specification evaluation and returns with lowest quote (L1) in financial bid would normally be awarded the contract subject to Post Qualification

19. Correction of Errors

- 19.1. Financial Bids determined to be substantially responsive will be checked by WBFDCL for any arithmetic errors. Arithmetic errors will be rectified on the following basis:-
- (a) Where there is a discrepancy between number and words, the number in words will prevail over the number in figures, to the extent of such discrepancy
- (b) The number stated in the Financial Bid will be adjusted by WBFDCL in accordance with the above procedure for the correction of errors and shall be considered as binding upon the

Bidder. If the Bidder does not accept the corrected number in respect of its Bid quote, his Bid will be rejected, and his Bid Security may be forfeited.

20. Award Criteria

- 20.1. Subject to Clause 22, WBFDCL will award the Project to the Bidder whose Bid has been determined to be substantially responsive to the bidding documents and who has offered the best Bid Price, provided that such Bidder has been determined to be eligible in accordance with the provisions of Clause 5.
- 20.2. In the event that two or more Bidders quoted the same price, the Corporation shall identify the selected Successful Bidder by draw of lots, which shall be conducted, with prior notice, in the presence of the Tie Bidders who choose to attend
- 20.3. In the event that the Highest Rank Bidder (H1) withdraws or is not selected for any reason in the first instance, the Corporation may invite 2nd Highest Rank Bidder (H2) to match the Price Bid of H1 and bid security of H1 shall be liable to be forfeited. However, in case H2 does not accept the offer, its bid security is not liable to be forfeited. But it is at the discretion of the Corporation to declared H2 as selected bidder for the same bid price as quoted by H2. Even if H2 does not accept the offer and/or fails to comply with the terms of the LOI, its Bid Security shall be liable to be forfeited. If no bidder is selected in first round of bidding, Corporation may invite from all the remaining Bidders to revalidate or extend their Bid Security, as necessary and ask the bidders to match the Bid of H1 (only financial bid in the "Second Round of bidding") If in the second round of bidding, only one Bidder matches the Highest Bidder, it shall be the Selected Bidder. If two or more Bidders match the said Highest Bidder in the second round of bidding, then the Bidder whose Bid was lower as compared to other Bidder(s) in the first round of bidding shall be the Selected Bidder. For example, if the third and fifth highest Bidders in the first round of bidding offer to match the said Highest Bidder in the second round of bidding, the said third highest Bidder shall be the Selected Bidder.
- 20.4. In the event that no Bidder offers to match the Highest Bidder in the second round of bidding, the Corporation may, in its discretion, invite fresh Financial Bids (the "third round of bidding") from all Bidders except the Highest Bidder of the first round of bidding, or annul the Bidding Process, as the case may be. In case the Bidders are invited in the third round of bidding to revalidate or extend their Bid Security, as necessary, and offer fresh Bids, they shall be eligible for submission of fresh Bids.

21. Corporation's Right to Accept any Bid and Reject any or all Bids

21.1. Notwithstanding anything contained in Clause 22 above, WBFDCL reserves the right to accept or reject any Bid and to annul the Bidding process and reject all Bids, at any time prior to award of contract, without thereby incurring any liability to the affected Bidder or Bidders or

any obligation to inform the affected Bidder or Bidders of the grounds for the WBFDCL's action.

22. Terms & Conditions

- 22.1. WBFDCL reserves the right to withdraw or include any item without assigning any reason thereof.
- 22.2. WBFDCL reserves the right to reject the Application of any Applicant who is a defaulter to the WBFDC Ltd., West Bengal Zoo Development Authority & the Forest Directorate, W B in respect of payment of dues.
- 22.3. The response should be submitted in a structured format as per the checklist appended with number on every page. Each page of the application should be signed by person(s) on behalf of the organization having necessary Authorization / Power of Attorney to do so, duly affixing the company seal. Applications containing false or inadequate information are liable for rejection. (Authorization Letter from the company should be furnished along with the application)
- 22.4. The evaluation of the applications for Shortlisting shall be carried out by the committee constituted for the purpose.
- 22.5. Any un-authenticated, alterations, erasures, overwriting, blanking out or discrepancies may render the tender submission invalid. The evaluation of the response will only be based on the documents submitted and the evaluation committee reserved the right to relax the evaluation criteria.
- 22.6. Response submitted by Fax or E-mail or any form other than mentioned above will not be acceptable and liable for rejection by WBFDCL.
- 22.7. The Bidder at his own cost responsibility and risk is encouraged to visit and examine the site and obtain all information that may be necessary for preparing the bid and entering into a contract before submitting its offer.
- 22.8. The intending Bidder shall clearly understand that whatever the outcome of the present invitation of bids, no cost of bidding shall be reimbursed by the Corporation/ Zoo Authority. The Corporation/ Zoo Authority reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any tenderer at any stage of bidding.
- 22.9. Conditional/incomplete tender will not be accepted under any circumstances.
- 22.10. All bids are exclusive of taxes and duties.
- 22.11. The Authority shall provide the License Right for a period of 3 years from the date of signing of the Agreement. The License of the Project Site will be provided on the as-is-where-is basis with the existing power and water connection on the site. Any additional

- load requirements with respect to power and water will need to be taken up by the Licensee at its own cost.
- 22.12. The Licensee will be required to submit a Security Deposit before entry into Agreement/ Contract equivalent to 2 months License Fee in the form of demand draft/ pay order No interest will be paid on Security Deposit. The Security Deposit shall be refunded within 30 days after the expiry of the Contract Period, after making due adjustment against any dues towards the Corporation/ Zoo Authority.
- 22.13. The Licensee has to pay the License Fee in advance for the particular month within or before the 7th day of every month. The Security Deposit is liable to forfeiture if the agency fails to deposit the License Fee as aforesaid with additional charges of 20% of the Monthly License Fee.
- 22.14. The License Fee shall be payable by way of demand draft/ pay order or as per the instruction as provided by the Authority from time to time.
- 22.15. The Licensee shall assigned or sublet the License in whole or part to any third person/entity.
- 22.16. The Licensee shall be responsible to make the Refreshment pavilion as an air-conditioned restaurant at its own cost subject to the approval of designs by the Authority.
- 22.17. No relaxation in License Fee shall be given to the Licensee for the loss on time required for making the refreshment pavilion as air conditioned restaurant.
- 22.18. The Licensee shall be responsible for payment of all other Government dues/ fees as well as levied to such Authority from the date of taking over to the Date of expiry of this contract without burdening the Corporation/ Zoo Authority on that account.
- 22.19. Taxes as applicable by Government from time to time has to be borne by the Licensee.
- 22.20. The Licensee cannot undertake any kind of construction, whether permanent or temporary in the licensed premises or outside. In rare cases, if needed in the interest of the Project or for security purposes, the Licensee can do temporary construction with prior approval of the Authority.
- 22.21. The Licensee will be liable to make good the damage caused to the facility of the ZGA, if any, during the erection/ creation of the refreshment pavilion/ restaurant. The full liability

- and responsibility will also lie over the agency due to any damage to the property, animal or human due to any unforeseen incident/ accident caused.
- 22.22. The Licensee shall keep the toilets always in neat and clean condition and will also be responsible for undertaking periodic cleaning of the Septic Tank at regular intervals.
- 22.23. The Licensee shall be responsible for keeping dry, organic & wet garbage separately and its disposal in line with applicable law. All cost associated with the same has to be borne by the Licensee.
- 22.24. The Licensee shall ensure that there will be no discharge of water in the open areas outside the Licensed premises.
- 22.25. The Licensee shall ensure that all cooking has to be done inside the Kitchen area only and no cooking shall be allowed outside.
- 22.26. The Licensee shall always keep the Licensed premises and surrounding areas neat and clean.
- 22.27. A separate private meter for the consumption of electricity for the facility will have to be installed by the Licensee at their own cost before commencement of their business.
- 22.28. The Corporation is building some kiosk in the Garden Area adjoining the licensed premises, for which the Corporation reserves the right to license the same to others on commercial terms for various activities.
- 22.29. The adjoining lawn can be used by the Licensee and other Vendors of the Kiosk for intended usage only.
- 22.30. Since it is an eco-sensitive zone, the Licensee shall adhere to the eco-sensitive principles and applicable laws.
- 22.31. All dispute in any matter arising out of this tender shall be settled by the Director, Zoological Garden, Alipore.
- 22.32. The Licensee has to bear all operational & other costs including utility charges towards operation, maintenance, and management of the facilities.
- 22.33. The selected Bidder (Licensee) shall be responsible for all costs associated with the operation, maintenance, and management including costs of fixtures and furnishing.
- 22.34. The Licensee cannot exhibit any advertisement except displaying his name. If the Licensee exhibits any advertisement other than his own name, his license will be terminated.
- 22.35. The Licensee shall provide 25% rebate on approved rate of food articles, tea etc. as prepared by them in the **Refreshment Pavilion** to the Zoo Garden Staff.

- 22.36. Without the approval of the Director, Zoological Garden, Alipore, rate/rates of any food items cannot be increased by the Licensee.
- 22.37. The usual terms of opening and closing the **Refreshment Pavilion** will as per the operational timeline of the Zoo. The Zoo remains closed for one day in a week and accordingly the operation of the Refreshment Pavilion will be closed on that day.
- 22.38. The Licensee must satisfy the Director, , Zoological Garden, Alipore about the hygenic conditions of their products and articles offered for sale as well as the reasonableness of the process of each item of food and drinks offered for sale at the stall and maintain all precautionary measure to be imposed by the competent authority from time to time.
- 22.39. The Licensee shall operate, maintain and manage the **Refreshment Pavilion** for at least 1 year, failing which the security deposit submitted by it will be forfeited and the agreement will be terminated.
- 22.40. The terms of the Agreement will be for a period of 1 year, which can be extended for a maximum of 3 years upon satisfactory performance, however each such extension shall not be for more than 1 year. In case of extension of the License Period, the License Fee quoted by the Selected Bidder shall be subject to upward revision @ 5% every year.
- 22.41. The Corporation/ Zoo Authority may terminate the Agreement/ Contract earlier by giving a two month notice. The Licensee also may terminate the Contract by issuing 2 months notice only after operate, maintain and manage the **Refreshment Pavilion** for a minimum period of 1 year.
- 22.42. Selected Bidder shall have to enter into a suitable agreement with the Corporation/ WBZA.

23. Pre Bid Meeting

A Pre-Bid meeting shall take place on date and time as mentioned in clause 3. The meeting will be organized online and interested applicant shall request for VC link to the email address given at Clause 12.

24. Site visit and verification of information

Bidders are encouraged to submit their respective Bids after visiting the Project site and ascertaining for themselves the site conditions, demand, location, surroundings, state of clinical and para-clinical facilities, climate, availability of power, water and other utilities for construction, access to site, handling and storage of materials, weather data, applicable laws and regulations, and any other matter considered relevant by them.

25. Acknowledgement by Bidder

- 25.1. It shall be deemed that by submitting the Bid, the Bidder has:
 - a. made a complete and careful examination of the Bidding Documents;

Any organization/ agencies willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System, through logging on to https:// wbtenders.gov.in (the web portal of West Bengal Tenders maintained by NIC). The organization / agencies are required to click on the link for e-Tendering site as given on the web portal
- 1.2. Each organization / agency is required to obtain a Class-II /Class III company Digital Signature Certificate (DSC) for submission of Application from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount.
- 1.3. The organization / agencies can search & download N.I.T. & Request for Proposal (RFP) Document(s) electronically from computer once they log on to the website.
- 1.4. Applications are to be submitted through online before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).
- 1.5. The Bidder are advised to submit the Application well in advance of the deadline as the Kolkata Forest Corporation Division will not be liable or responsible for non-submission of the bids or submission of incomplete bid on account of any technical glitches or any problems in connectivity services used by the Bidder
- 1.6. An Bidder desirous of taking part in RFP process shall login to the e-Procurement portal of the Government of West Bengal http://wbtenders.gov.in using his login ID and password.

- **4.** If verification is successful, the fund will get credited to the respective Pooling account of the State Government office/PSU/Autonomous body/Local Body/PRIs, etc maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road, Kolkata for collection of Application Fees.
- **5.** Hereafter, the Bidder will go to e-procurement portal for submission of his bid.
- **6.** But if the payment verification is unsuccessful, the amount will be returned to the Bidder's account.

APPENDIX 2 – Form of Agreement

This Agreement is made on this Day of Between

the Director, Zoological Garden, Alipore Kolkata 700027 as the 1st Party (hereinafter called the Corporation), which include its successors

Whereas

- 1. the 1st party has developed a Refreshment Pavilion in the Zoological Garden at Alipore, Kolkata.
- 2. The 1st Party has decided to rope in the services of a suitable agency for operation, maintenance and management of the Refreshment Pavilion through an open, transparent and competitive bidding process.
- Accordingly, the 1st Party floated Request for Proposal to identify and select suitable agency who
 are interested in carrying out the operation, maintenance and management of the said
 Refreshment Pavilion,
- 4. The 2nd Party showed its interest in providing its services and had participated in the RFP floated by the 1st Party and has subsequently been selected by the 1st Party to undertake operation, maintenance and management of the Refreshment Pavilion.
- 5. Towards the same, the 1st Party agrees to grant and the 2nd Party agrees to accept a license to use the land and structures of the Refreshment Pavilion (described in the Appendix 3) for the purpose herein stated with the rights and subject to the conditions and limitations hereinafter specified.
 - A. The term of the Agreement will be for a period of one year which can be extend twice for one year subject to satisfactory services and yearly review.
 - B. That the 2nd Party may exercise the following rights:
 - a. The License Fee quoted by the Selected Bidder shall be subject to upward revision @ 5% every year.
 - b. The right for himself, his servants and agents to enter and leave in the said Zoological Garden, Alipore by the main entrance (excepting by the turnstime meter gate) and by all other entrances thereof used by and open to the public only for the purpose of the license as stated herein below and for no other purpose.
 - The right to occupy for the purpose if cooking and catering to visitors inside the said
 Zoological Garden, Alipore the land and structure described in the Appendix 3 subject

- to such directions as the Director, Zoological Garden, Alipore may from time to time give or impose.
- d. The right to remove any structure erected at the cost of the 2nd Party after/ on or before the expiry of contract upon taking permission of the Director or to make over to the Director, Zoological Garden, Alipore may pay.
- C. The condition upon which the said license or rights granted are as follows:
 - a. The 1st Party shall provide the License Right on as-is-where-is basis with the existing power and water connection on the site. Any additional load requirements with respect to power and water will need to be taken up by the 2nd Party at its own cost.
 - b. The 2nd Party shall pay to the 1st Party the sum of Rs (bidder quoted price) plus applicable taxes as License Fee per month on or before the 7th of each month.
 - c. The 2nd Party shall in case of failure to make payment within the specified period may pay an additional charge equivalent to 20% of the said license fee.
 - d. The 2nd Party shall not be allowed to keep the licensed premises open to visitors after closure of the Garden.
 - e. The 2nd Party shall not cause to be played or give any dance performance inside the licensed area.
 - f. The 2nd Party shall provide at its own expenses sufficient and competent staff of attendants and waiters to attend and wait upon his customers in the licensed premises and shall be responsible for good behaviour.
 - g. The 2nd Party will have to allow 25% rebate on approved rate of food articles, tea etc as prepared by them in their stall to the staff of the 1st Party.
 - h. The 2nd Party shall only use cooking gas/ or electrical induction/ microwave for preparation of their saleable items of food. Usage of conventional challah with coal will not be permitted.
 - i. The refreshment supplied by the 2nd Party shall be of the best quality only and shall be sold at prices that are reasonable and approved by the 1st Party from time to time.
 - j. The 2nd Party shall exhibit a prominent part of the said licensed premises a list of the saleable items both in Bengali and English with the scale of charges noted against each item. Sale of food and drinks not listed and approved is strictly prohibited.
 - k. The 2nd Party shall conduct his business with civility and propriety and shall maintain peace and order within the licensed premises.
 - I. The 2nd Party will not be allowed to sell any food items in polythene bag and tetra pack.
 - m. The Licensee will be required to submit a Security Deposit before entry into Agreement/ Contract equivalent to 2 months License Fee in the form of demand draft/ pay order. No interest will be paid on Security Deposit. The Security Deposit shall be

- refunded within 30 days after the expiry of the Contract Period, after making due adjustment against any dues towards the Corporation/ Zoo Authority.
- n. The Licensee has to pay the License Fee in advance for the particular month within or before the 7th day of every month. The Security Deposit is liable to forfeiture if the agency fails to deposit License Fee as aforesaid with additional charges of 20% of the Monthly License Fee.
- o. The License Fee shall be payable by way of demand draft/ pay order or as per the instruction as provided by the Authority from time to time.
- p. The 2nd Party shall not assigned or sublet the License in whole or part to any third person/ entity.
- q. The 2nd Party shall be responsible to make Refreshment pavilion as air conditioned restaurant at its own cost subject to approval of designs by the Authority.
- r. No relaxation in License Fee shall be given to the 2nd Party for the loss on time required for making the refreshment pavilion as air conditioned restaurant.
- s. The 2nd Party shall be responsible for payment of all other Government dues/ fees as well as levied to such Authority from the date of taking over to the Date of expiry of this contract without burdening the Corporation/ Zoo Authority on that account.
- t. Taxes as applicable by Government from time to time has to be borne by the 2nd Party.
- u. The 2nd Party can not undertake any kind of construction, whether permanent or temporary in the Licensed premises or outside. In rare case, if needed in the interest of the Project or for security purposes, the Licensee can do temporary construction with prior approval of the 1st Party.
- v. The 2nd Party will be liable to make good the damage caused to the facility of the ZGA, if any, during the erection/ creation of the refreshment pavilion/ restaurant. The full

- liability and responsibility will also lie over the agency due to any damage to the property, animal or human due to any unforeseen incident/ accident caused.
- w. The 2nd Party shall keep the toilets always in neat and clean condition and will also be responsible for undertaking periodic cleaning of the Septic Tank at regular interval.
- x. The 2nd Party shall be responsible for keeping dry, organic & wet garbage separately and its disposal in line with applicable law. All cost associated with the same has to be borne by the 2nd Party.
- y. The 2nd Party shall ensure that there will be no discharge of water in the open areas outside the Licensed premises.
- z. The 2nd Party shall ensure that all cooking has to be done inside the Kitchen area only and no cooking shall be allowed outside.
- aa. The 2nd Party shall always keep the Licensed premises and surrounding areas neat and clean.
- bb. Separate private meter for consumption of electricity for the facility will have to be installed by the 2nd Party at their own cost before commencement of their business.
- cc. The 1st Party is building some kiosk in the Garden Area adjoining the Licensed premises, for which the 1st Party reserves the right to license the same to others on commercial terms for various activities. The adjoining lawn can be used by the 2nd Party and other Vendors of the Kiosk for intended usage only.
- dd. Since it is an eco sensitive zone, the 2nd Party shall adhere to the eco sensitive principles and applicable laws.
- ee. All dispute in any matter arising out of this tender shall be settled by the Director, Zoological Garden, Alipore.
- ff. The 2nd Party has to bear all operational & other costs including utility charges towards operation, maintenance and management of the facilities.
- gg. The 2nd Party shall be responsible for all costs associated with operation, maintenance and management including costs of fixtures and furnishing.
- hh. The 2nd Party can not exhibit any advertisement except displaying his name. If the Licensee exhibits any advertisement other than his own name, hiss license will be terminated.
- ii. The 2nd Party shall provide 25% rebate on approved rate of food articles, tea etc as prepared by them in the **Refreshment Pavilion** to the Zoo Garden Staff.
- jj. Without the approval of the Director, Zoological Garden, Alipore, rate/rates of any food items can not be increased by the 2nd Party.
- kk. The usual terms of opening and closing the **Refreshment Pavilion** will as per the operational timeline of the Zoo. The Zoo remains closed for one day in a week and accordingly the operation of the Refreshment Pavilion will be closed on that day.
- II. The 2nd Party must satisfy the Director, , Zoological Garden, Alipore about the hygenic conditions of their products and articles offered for sale as well as the reasonableness

of the process of each item of food and drinks offered for sale at the stall and maintain all precautionary measure to be imposed by the competent authority from time to time.

- mm. The 2nd Party shall operate, maintain and manage the **Refreshment Pavilion** for at least 1 year, failing which the security deposit submitted by it will be forfeited and the agreement will be terminated.
- nn. The terms of the Agreement will be for a period of 1 year, which can be extended for a maximum of 3 years upon satisfactory performance, however each such extension shall not be for more than 1 year. The License Fee quoted by the Selected Bidder shall be subject to upward revision @ 5% every year.
- oo. The 1st Party may terminate the Agreement/ Contract earlier by giving a two month notice. The 2nd Party also may terminate the Contract by issuing 2 months notice only after operate, maintain and manage the **Refreshment Pavilion** for a minimum period of 1 year.
- pp. The 2nd Party shall at its own cost arrange all earthen ware, glass, china ware, chair, table and other necessary articles for clean and efficient services.
- qq. The 2nd Party shall keep the interior and exterior of the licensed premises in proper order and condition, to the satisfaction of the 1st party.
- rr. The 2nd Part shall regularly pay all the license imposition lawfully payable for carrying of the said business including Municipal License, Income Tax and GST.
- ss. The grant of License is conditional upon the 2nd Party obtaining and producing income tax and GST certificate.
- tt. The license shall be revoked upon the insolvency of the 2nd Party and on the breach of any conditions herein specified.
- uu. The License may be terminated by the 1t Party after giving 2 month's notice in writing. If the termination is sought by the 2nd Party before expiry of 1 year from the date of contract, the security deposit as submitted by the 2nd Party shall be forfeited and the 2nd Party shall pay the License Fee for the rest of the period of Contract. Failing which a certificate case will be initiated for recovery of the License Fee as aforesaid and the 2nd Party will be blacklisted for participating in the tender of any form of ZGA for three years. The 2nd Party may also terminate the Contract by giving 2 months notice after catering the licensed premises for at least 1 year.
- vv. On termination or sooner termination of this Agreement on the revocation of this License, the 2nd Party shall discontinue to use and shall yield up to licensed premises in good condition, reasonable wear and tear expected and the 1st party shall be entitled to take the possession thereof without recourse to any legal action or proceedings.
- ww. The License hereby granted is personal and shall not be assignable under any circumstances.
- xx. In the event of the 2nd Party closing the business for some reasons or other during the pendency of this Agreement, the 2nd Party shall have to make good all losses likely to

- be sustained by the 1st Party and in that case the Security Deposit of the 1st Party will be forfeited except under clause 2 (s).
- yy. The 2nd Party shall whenever called upon to do so by the 1st Party or any superior officer of the ZGA shall be allowed for inspection of the licensed premises.
- zz. The 2nd Party shall not object to the same of refreshment within or outside the said Garden by other vendors or other licensee.
