- 2. Intending Bidder/ Tenderer should produce credentials of one similar nature (Supply of furniture) of the minimum value equivalent to Rs. 2.50 Lacs of tender amount of during 5 (five) years prior to the date of issue of the Tender or 2(two) similar nature of completed work, each of the minimum value is Rs. 1.90 Lacs of tender during 5(five) years prior to the date of issue of this tender.
- 3. Consortium or Joint Venture of any sort will not be allowed.

Bid Security

The Bidder shall furnish, as part of its Bid, a Bid Security equivalent to Rs. 12,000/-(Rupees Twelve Thousand) only. EMD has to be payable in ONLINE mode as per Finance Department G.O. No 3975 F (Y) dated 28th July 2017 (exempted for applicants who are registered with MSME and NSIC for the services for which enlistment is sought on production of documentary evidence).

d) The bidder should adhere to laws of the land and rules, regulations and guidelines issued by the various regulatory, statutory and Government authorities. It should also ensure that it has complied all required legal compliances and has the necessary permission/ licenses to do the job.

The Bidder will be responsible for the authenticity and genuineness of the work undertaken and will be liable for breach of contract if discrepancies/ violations are observed.

- 1.8. The successful tenderer shall have to submit a security deposit of 10% of the tender price which will be returned to the tenderer upon completion of warranty period of 2 years.
- 1.9. The product should bear warranty of 2 years from the date of supply.
- 1.10. The place of Arbitration will be Kolkata and the language shall be English

- 1.11. The award of the Arbitrator shall be binding on both the parties.
- 1.12. All disputes and court cases are subject to the jurisdiction of the Calcutta High Court only.
