1. Eligibility Criteria for participation in tender:

- 1. The bidder should have been all necessary permission, registration and license as applicable. The bidder should have valid PAN, GSTIN Registration, ESI and EPF registrations.
- 2. All categories of prospective Tenderers shall have to submit valid and up to date Professional Tax receipt challan, GST registration certificate, Income Tax Return Acknowledgement receipt for last 3 years, PAN card issued by Income Tax Department, Voter ID card, Aadhar Card and Trade licence for similar nature of work in respect of the prospective tenderer.
- 3. The Bidder may be Proprietorship Firm / Partnership Firm / Private Limited Company / Public Limited Company/ Limited Liability Partnership / Cooperative Society/ Society. No consortium/ joint venture of any sort will be allowed.
- 4. The Bidder should either be Manufacturer / authorized dealers of the items as mentioned above.
- 5. In case of Authorized Dealer Authorization certificate to be enclosed with this Tender.

2. Cancellation of Tender:

3. Instruction to Bidders

- a. Any condition or qualification or any other stipulation contained in the Bid shall render the Bid liable to rejection as a non-responsive Bid. The bids shall be unconditional, firm and irrevocable.
- b. The Bidders shall be responsible for all costs associated with the preparation of their Bids and their participation in the Bid. The Corporation will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.
- c. Any entity which has been barred by the [Central/ State Government, or any entity controlled by it] from participating in any project, and the bar subsists as on the date of bidding, would not be eligible to submit a Bid.

- A. Envelop 1: Technical Bid: The Bidder shall submit the following document as part of its Technical Bid
 - i) Details of the Bidder.
 - ii) Proof towards Manufacturing unit/ Authorized Dealer or Distributor.
 - iii) EMD/ Security Deposit.
 - iv) Trade License (in case of proprietorship firm/ partnership firm)
 - v) In case of Company Please enclose Memorandum and Articles of Association along with certificates of incorporation, and date of commencement of business etc.
 - vi) In case of Partnership Firm, registered under the Partnership Act., 1932 Please enclose details of partners, details of their business and partnership deed etc. duly attested by Notary
 - vii) GST Certificate
- B. **Envelop 2** Financial/Price Bid: The Bidder shall submit all-inclusive financial quotes as its Financial Bid. The price bid quoted by the Bidder shall be inclusive of taxes & duties including GST. The Price Bid shall be exclusive of Freight, which will be paid on actual basis. **The Price Bid quoted by the Bidder shall remain valid for 6 months.**

7. The queries and original document must be submitted to the address mentioned in clause 4 above.

8. Bid Security

a. The Bidder shall furnish, as part of its Bid, a Bid Security equivalent to Rs. 15000/- -(Rupees fifteen thousand only).in the form of Bank DD/Cheque favoring Divisional Manager, Kolkata Forest Corporation Division, payable at Kolkata. Bid Security is exempted for applicants who are registered with MSME and NSIC for the services for which enlistment is sought on production of documentary evidence

9. WBFDCL's right to vary Scope of Work at the time of Award:
